In consideration of Whatz-Up Family Fun Park (Whatz-Up) furnishing services and/or equipment to enable me or my minor child to participate in paintball games and activities, I hereby agree as follows:

I fully understand and acknowledge that: (a) risks and dangers exist in my/my minor child's use of paintball equipment and my/my minor child's participation in paintball activities; (b) my/my minor child's participation in such activities and/or use of such equipment may result in my/my minor child's death, illness or injury including, but not limited to, bodily injury, disease, strains, sprains, fractures, partial and/or total paralysis, eye injuries, blindness, heat stroke, heart attack or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees or agents of Whatz-Up, the negligence of me, my minor child or other participants, the negligence of non-participants, accidents, breaches of contract, the forces of nature or other causes; (d) these risks and dangers may arise from foreseeable or unforeseeable causes; and (e) by my/my minor child's participation in these activities and/or use of equipment. I hereby assume all risks and dangers of and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, employees or agents of Whatz-Up or by any other person, the forces of nature or any other causes whatsoever.

I, on behalf of myself/my minor child, my/my minor child's personal representatives, and my/my minor child's heirs, hereby voluntarily release, waive, discharge, hold harmless and indemnify Whatz-Up and it owners, employees and agents from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my/my minor child's use of paintball equipment or my/my minor child's participation in paintball activities.
